Certification of systems
<ul style="list-style-type: none"> - <i>Systems certification covers in particular:</i> - Quality Management - Environmental Management - Food Safety Management - Occupational health and safety management
Business office
<ul style="list-style-type: none"> - All intermediate activities acting in the economic and commercial field with the exception of regulated activities. - Commercial representation and sales agency - Telemarketing centre - All trading activities
Management of industrial zones
<ul style="list-style-type: none"> - All service activities related to the management of industrial zones: Development, sanitation, protection and guarding and other routine activities related to the administration of these zones
Administration of companies in all sectors of activity (Société de Gestion des participations de l'Etat-SGP)
<ul style="list-style-type: none"> - Administration of undertakings comprising the acts of guidance, management, representation and control, related to the ownership and/or control of the share capital of undertakings of investment management companies (SGP) related to the current management activity on an ancillary basis

<ul style="list-style-type: none"> - Rental of workspace for the benefit of businesses and third parties - Business domiciliation and secretarial services - Design and delivery of support programmes for innovative and startup project promoters, on all technical, administrative and commercial aspects, on its own behalf or for the benefit of third parties - Organization of seminars and training events in innovation and technology, Advice in the field of business creation - Innovation promotion services for enterprises (open innovation,programmes,bootcamps for large national and multinational groups,.. etc - Consulting and networking for investment in startups - Technology Prototyping Services - Production and publishing of content related to entrepreneurship and innovation
Electronic Commerce (E-Commerce)
<ul style="list-style-type: none"> - Any activity for which an e-supplier proposes or insures, an e-consumer; the provision of goods and services by remote and electronic communications (with the exception of products prohibited from transactions by means of electronic communications, in accordance with Articles 3 and 5 of Law N°18-05 of 10 May 2018 on electronic commerce, cited below: - Gambling, online betting and lotteries - Alcoholic beverages and tobacco - Pharmaceuticals - Products infringing intellectual, industrial or commercial property rights - Any good or service prohibited by the legislation in force - Any good or service that requires an authentic act - Sensitive materials, equipment and products defined by the regulations in force as well as any other products and/or services that may harm national defence interests, public order and public safety)
Specialized Design Services
<ul style="list-style-type: none"> - Design and product design services by reconciling aesthetic considerations with technical or other requirements, such as: - Furniture creation - Creation of clothing, footwear and jewellery - Creation of models for other miscellaneous consumer goods. - Packaging Design Services. - Production of three-dimensional models - Graphic design service including: Advertising, illustration, print poster
Industrial Engineering Company (Technology watch service, consultancy, assistance and all training related to the company's purpose)
<ul style="list-style-type: none"> - Development and implementation of all types of industrial investment projects (engineering, procurement, construction) - All kinds of technical and engineering studies in the industrial field; - Carrying out all work relating to industrial engineering
